

TERMS AND CONDITIONS

“Client” is defined as the authorized party providing the personal testimony, picture files or photographs and/or logos for production. “The Testimony Card” is defined as any employee, individual, or printing company providing production services on behalf of the client.

Client

If you are placing an order in the name of a company, you must be legally authorized to place the order for the company.

Pricing

Every effort will be made to notify clients of price increases in advance. Quotations, either emailed or faxed will be honored for up to 30 days after the quote date. Changes made by “The Testimony Card” to client supplied files can be subject to extra charges.

Terms of Sale

“The Testimony Card” accepts cash, personal or company check. Payment of product is due when the client approves the artwork to be printed. In the event of non-payment that leads to dispute and/or litigation, the client agrees to pay all legal and collection fees incurred by “The Testimony Card”.

Sales Tax

All orders are subject to sales tax. If client is tax exempt, exemption certificate must be sent or faxed to “The Testimony Card” at the time of placement of order.

Imaging

“The Testimony Card” will reproduce color from digital files as closely as possible, but may not exactly match color and density due to limitations in printing process. Reasonable variation in color between submitted proof will be considered acceptable print quality. Clients must provide high quality (300 dpi recommended) resolution images. “The Testimony Card” is not liable for images which print poorly due to low resolution.

Errors and Omissions

“The Testimony Card” is not responsible for any errors and omissions which are approved by the client. The client is solely responsible for errors missed during the proofing process of either artwork supplied by the client or artwork created by “The Testimony Card”.

Indemnification

The client will indemnify and hold harmless “The Testimony Card” from any loss, expense and damages arising out of violation of copyright or trademark laws from the illegal use of any all images, photographs, slogans, trademarks, or graphical work supplied by the client.

Usage
